Bids received for the subject project were publicly opened at 10:00 am on Tuesday, February 9, 2016 as advertised. The table below summarizes the nine (9) bids received and provides a comparison to the Engineer's Estimate of probable construction costs.

#26-2016 A RESOLUTION TO ENTER INTO AN AGREEMENT WITH ACCADIA SITE CONTRACTING, INC. FOR THE SUMMIT STREET RECONSTRUCTION PROJECT PIN 4754.36

Motion of Councilperson

WHEREAS, a Project for the Reconstruction of Summit Street City of Batavia, P.I.N. 4754.36 (the Project) is eligible for funding under Title 23 U.S.Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the City of Batavia has previously agreed to advance the Project by administering the work; and

WHEREAS, a competitive bid was made by Accadia Site Contracting, Inc., (5636 Transit Road, Depew, NY 14043) for the value of \$1,857,753.70 to construct the project; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Batavia that the City Council President is hereby authorized on behalf of the City to execute an agreement with Accadia Site Contracting, Inc. for the Summit Street reconstruction.
