# **Council President's Report**

Councilperson Jankowski presented the 2012-2013 Business Owner of the Year Award to Blue Pearl Yoga.

Councilperson Deleo presented the 2012-2013 Home Owner of the Year Award to Jim and Kathy Owen of 2 Redfield Parkway.

Councilperson Canale presented a proclamation to Lester Hill to thank him for his 33 plus years of service to the City of Batavia. Les was a dedicated and committed employee for the Department of Public Works. Les began as a laborer and eventually established the current paving management program. Thank you to Lester Hill.

Council President Hawley announced that the next regular City Council Conference Meeting would be held on Monday, February 24, 2014 at 7:00 PM at the City Hall Council Board Room, 2<sup>nd</sup> Floor, City Centre.

### **City Manager's Report**

Mr. Molino noted that there was nothing specific to report and they would discuss more at the next conference meeting about Brownfield issues that may affect the City's efforts regarding cleanup of those properties.

### **Committee Reports**

Vibrant Batavia gave a presentation to Council. Marty MacDonald thanked Council for letting them present, he showed a timeline of the work they had done and highlighted their accomplishments. He noted that Leanna Dirisio had been hired in the summer of 2013, coffee talks were held, neighborhood surveys were conducted and a Fall Frolic was held in November. He also noted that city residents came together on Facebook and created a Batavia neighborhood watch. Ms. Dirisio spoke about the Holiday Tour of Homes, the attendance at St. Joe's career day, promotion of the centennial celebration, creation of the Vibrant Times publication, social media launch and Shop Around Batavia. Dave Snyder gave a financial update and explained the priorities of the committee for 2014. Councilperson Pacino asked how the average person could donate to Vibrant Batavia. Mary Valle noted that there would be a "big ask" campaign where donations could be made. Councilperson Jankowski noted that the motorcycle rally was looking for someone to chair the event, noted it had been making money, and thought it might be an event Vibrant Batavia would be interested in. He also noted there had been some concern from businesses who were selling discounts similar to the Shop Around cards about competition amongst the businesses. Mrs. Valle stated that she needed a specific example because she was not aware of any other businesses selling the same type of thing. Ms. Dirisio noted that they wanted to continue to work with the groups in the City once the weather got better and to continue to make strides in the community.

### **Public Comments**

John Roach, 116 Grandview Terrace, noted that he had been looking at a website called See Through New York where the public could check salaries and he noted that Ms. Kuzon received a higher salary than the City Manager. He felt there was a discrepancy with how much the City Manager was receiving as well and wondered if the website was wrong. He was curious about the pay rate for the assistant City Manager and asked if positions were being paid from other funds.

### **Council Responses to Public Comments**

Councilperson Doeringer asked why there was money in the water and sewer funds for the City Manager wages. Mr. Molino noted that he worked in those departments and divided his time accordingly. Mr. Molino went on to say that administrative staff salaries are also divided amongst the different funds based on the work they do. He noted that salaries didn't always mean the top wage earners and that the City shows wages based on a fiscal year which is not always consistent with how other websites may report earnings figures.

**BE IT FURTHER RESOLVED**, that the City Clerk publish or cause to be published a public notice in the official newspaper of the City of said public hearing at least five (5) days prior thereto.

### **ORDINANCE #001-2014**

# AN ORDINANCE ADOPTING THE 2014-2015 BUDGET AND DETERMINING THE AMOUNT OF TAX TO BE LEVIED ON ALL REAL PROPERTY FOR THE 2014-2015 FISCAL YEAR

**BE IT ENACTED,** by the Council of the City of Batavia, New York:

**SECTION 1.** The proposed Budget for 2014-2015, submitted by the City Manager pursuant to Sections 16.3, 16.4, and 16.5 of the City Charter on January 13, 2014, as amended, setting forth the estimates of revenues and expenditures for the fiscal year 2014-2015 of the various funds of the City of Batavia, namely, General Fund, Water Fund, Sewer Fund, and Workers' Compensation Fund is hereby approved and that the several amounts allowed as estimated expenditures be and are hereby appropriated to the use of the several departments of the City of Batavia for the purpose set forth in each estimate in the proposed budgets for the fiscal year 2014-2015.

**SECTION 2.** The City Council does hereby finally ascertain, fix, and determine that the entire amount necessary, proper, and legal be raised by tax to defray the expenditures of the City of Batavia for the fiscal year of 2014-2015 is \$5,099,981.

**SECTION 3.** The sum of \$5,099,981 the entire amounts heretofore ascertained, fixed, and determined as necessary, proper, and legal be raised by tax to defray the expenditures of the City of Batavia for the fiscal year 2014-2015, be and the same is hereby levied on all the real property subject to taxation by the City of Batavia according to valuation upon the assessment roll for the fiscal year 2014-2015.

**SECTION 4.** The amounts to be raised by taxation as hereby stated for City purposes is hereby a warrant upon the Clerk-Treasurer to spread and extend such levies upon the current assessment tax roll and to collect the same.

**SECTION 5.** The budget summaries, as filed in the Clerk-Treasurer's Office of the various funds of the City of Batavia, are made a part hereof and are hereby declared to be part of the Ordinance.

**SECTION 6.** This Ordinance shall become effective April 1, 2014.

# A LOCAL LAW TO AMEND §184-41(A), (B), (C), AND (O) OF THE CODE OF THE CITY OF BATAVIA TO ESTABLISH NEW WATER RATES, METER FEES AND A CAPITAL IMPROVEMENT FEE

**Be It Enacted** by the City Council of the City of Batavia, New York as follows:

### Section 1. § 184-41. Water rates.

# RESOLUTION IN OPPOSITION TO EXPANDING CASINO GAMING IN WESTERN NEW YORK

### **Motion of Councilperson Deleo**

WHEREAS, in September 1973, 11 western New York counties and two cities established

the Western Region Off—Track Betting Corporation, they being the counties of Cattaraugus, Chautauqua, Erie, Genesee, Livingston, Monroe, Niagara, Orleans, Seneca, Steuben, and Wayne, as well as the cities of Rochester and Buffalo as enabled by state law; and

**WHEREAS**, these municipal "stockholders" chose to exercise that local option to form such a corporation that dictated local control by those municipalities over such gaming activities in their respective communities; and

**WHEREAS**, the start-up costs of this enterprise were funded solely by these initiating counties from their own treasuries of taxpayer money and represented no state money nor allowed for any state sharing of this purely local venture; and

**WHEREAS**, since those eleven counties voted to form Western Region Off-Track Betting. Corporation, an additional four western New York counties (Wyoming, Schuyler, Oswego, and Cayuga) have joined them in the local control of such gaming activities that has since generated over \$215 million in operating and surcharge revenues to the taxpayers of those participating municipalities; and

**WHEREAS,** the Seneca Nation of Indians has recently initiated a process to locate a full Las Vegas-style gaming casino in Monroe County; and

**WHEREAS,** the participating municipalities of Western Region OTB as its shareholders have a *pro-rata* financial interest in the \$69 million of net equity reinvested in its 30-plus corporately-owned branch facilities and the track and casino at Batavia Downs; and

**WHEREAS**, the addition of another casino located in Western New York owned and operated by the Seneca Nation in the area will over saturate the regional gaming marketplace and cause financial distress to Western Region Off Track Betting and to the 17 municipal stakeholders, and

**WHEREAS,** Batavia Downs Gaming and Western Region Off Track Betting Corporation are located in the City of Batavia, and

**WHEREAS,** nearly 460 local, full- and part-time jobs are supported by Batavia Downs Casino, with wages and salaries for employees totaling more than \$5 million annually, and

WHEREAS, Batavia Downs Gaming annually generates over \$18 million in economic output for the region, reinvests nearly \$3 million into the local economy with the purchase of goods and services (including construction) from business in the area, and directly and indirectly provides over \$3.5 million in revenues for Genesee County municipalities; and

**WHEREAS,** Batavia Downs Gaming has contributed \$94.5 million to New York State education, having never missed a payment; and

**WHEREAS,** Batavia Downs Gaming has proven to be a successful Public Benefit Corporation to the community; and

WHEREAS, an additional casino in Western New York will not only have negative consequences for surrounding communities throughout the region, it would have a devastating effect on hundreds of residents and small business owners in the Batavia area that rely on Batavia Downs Gaming for their livelihood; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Batavia City Council does hereby oppose the location of an additional casino located in Monroe County owned and operated by the Seneca Nation; and

**BE IT FURTHER RESOLVED,** that copies of this resolution be sent to each member of the New York State Legislature representing the City of Batavia, the Governor of New York and members of the Genesee County Legislature; and

**BE IT FURTHER RESOLVED,** that members of the New York State Legislature representing Batavia, the Governor of New York and members of the Genesee County Legislature be urged to join the City Council in the opposition of any new proposed casino in Western New York west of Route 14.

Seconded by Councilperson Pacino and on roll call approved 8-1. Councilperson Christian voted no.

Councilperson Christian asked why there was opposition to this. Councilperson Deleo noted that the Seneca Nation was looking to build a casino in Henrietta and that it would greatly hurt the City because of the VLT aid we get from the local casino. He noted that the governor was asking if there was any opposition and thus wanted to voice the City's opposition.
