NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Batavia re-appoints Dawn Fairbanks, Human Resource Specialist to serve as the ADA Coordinator for the City of Batavia.

BE IT FURTHER RESOLVED, that the City Council of the City of Batavia reappoints City Manager Jason Molino to serve as the Fair Housing Officer for the City of Batavia.

RESOLUTION TO AUTHORIZE THE CITY COUNCIL PRESIDENT TO EXECUTE AN EASEMENT WITH THOMPSON BUILDS, INC.

WHEREAS, 13-15 Jackson Street Rear, SBL #84.049-1-24 is located in the downtown core of the City and important to re-develop in order to attract new business, activity and economic development within the City; and

WHEREAS, the City and the Batavia Development Corporation have worked with Thomson Builds, Inc. to redevelop the property improving the property value and contribution to the revitalization of downtown; and

WHEREAS, the City requires a permanent easement for the purpose of re-construction of 13-15 Jackson Street Rear;

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of Batavia, that the City Council President is hereby authorized on behalf of the City to execute the easement with Thompson Builds, Inc. as stated in "Attachment A" below.

MOTION TO ENTER EXECUTIVE SESSION

Motion of Councilperson Pacino

WHEREAS, Article 7, Section 105(1)(h), of the Public Officer's Law permits the legislative body of a municipality to enter into Executive Session to discuss "...the proposed acquisition, sale, or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof...".

WHEREAS, Article 7, Section 105(1)(e), of the Public Officer's Law permits the legislative body of a municipality to enter into Executive Session to discuss "...collective negotiations pursuant to article fourteen of the civil service law...".

WHEREAS, Article 7, Section 105(1)(d), of the Public Officer's Law permits the legislative body of a municipality to enter into Executive Session to discuss "...proposed, pending or current litigation...".

WHEREAS, Article 7, Section 105(1)(f), of the Public Officer's Law permits the legislative body of a municipality to enter into Executive Session to discuss "...the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation...".

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Batavia, that upon approval of this Motion, the City Council does hereby enter into Executive Session.

Seconded by Councilperson Russell and all of Council approved.
