#### I. Call to order:

The meeting was opened at 4:50 pm by Paul Schulte.

#### III. Public Hearings:

A. 12 Ellicott Street – Fence, siding, roof, and change façade colors. Mr. Schulte opened the public hearing and explained that the property is in the historic district. He gave the floor to the owner of Rancho Viejo Restaurant to explain the project. Mr. Guillermo addressed the commission stating that he would like to change the color of the façade. He approached the commission and showed them different color samples. He showed pictures of what the façade would look like. Ms. Burkel asked for the originals because the copies were not clear. Ms. Smith approached the commission with the original color scheme and three other color schemes that Mr. Guillermo stated they would not be using. The commission looked at the different color scheme and Ms. Burkel pointed out a particular set of colors and stated that this color scheme would be a little more subtle and help achieve the look that they would want.

Mr. Guillermo would also like to put a tile roof on the property. This would be a terracotta tile that would go with the color scheme.

Mr. Guillermo explained that he wanted to put up a stone wall in between each of the existing posts on the North side of the building. They are hoping the walls will help reduce the snow blowing on the walkway for customers. Ms. Burkel asked Mr. Panek if there would be any issues with the code regarding the wall. Mr. Panek stated that he has already discussed ways to build the wall with Mrs. Guillermo without having any code issues.

The Commission also discussed the fence that would surround the front grass area in front of Rancho Viejo. It is a ranch style fence that will be brown.

Motion was made to approve the proposal with the colors of the façade to be hacienda tile and Thai ice tea; the stone wall to be Novik Stone copper color; ranch style fence; and terracotta tile for the roof for 12 Ellicott Street as presented.
