**City of Batavia
Residential Rehabilitation Program**

The Residential Rehabilitation Program (RRP) may provide grant and loan assistance to qualified owner-occupant households to enable them to make essential improvements to their properties. To be eligible, you must be the owner and occupant of a single family dwelling in the City of Batavia. Your total annual household income may not exceed the income limits shown below for your household size:

Priority will be given to households that qualify as low or very-low income households. In addition, the mortgage (if any) and property taxes, property maintenance charges, and water and sewer charges for the property must be current. Residents who are buying a house under a land contract or rental agreement with option to buy will not be eligible for the program.

Type of Assistance

Assistance under the Residential Rehabilitation Program will not exceed \$24,500 per structure. For owner occupants who qualify as low or very low income, 100 percent of the project cost, up to a maximum of \$24,500 will be provided as a grant. Grants do not have to be repaid unless the property is sold or transferred within 5 years. The amount to be repaid will depend on the length of time between the completion of the work and the sale or transfer of the property. For owner occupants who are moderate income, 75 percent of the project, up to a maximum of \$18,375 will be provided as a grant. The remaining project cost will be provided as a deferred loan at an interest rate of 0 percent. No monthly payments will be required on the deferred loan; loan repayment in full would be due at the time the property is sold or property title transferred.

Eligible Improvements

The purpose of the Residential Rehabilitation Program is to provide funds to assist homeowners in making essential home repairs and to correct basic structural deficiencies that present health and safety hazards to residents. Eligible improvements include repairs to major building systems (roof, electrical, heating, plumbing) as well as code items and other necessary repairs. Eligible improvements may also include measures to mitigate flood hazards for houses located in the flood zone. The program does not provide funds for basic remodeling costs. Priority will be given to properties in greatest need of rehabilitation.
