Subject: 2016 Alum Sludge Removal at WWTP, Contract #2015-2 (R)

On April 21, 2016 an advertisement for bids was issued for the "Cleaning of Secondary Pond S-1" at the City of Batavia Wastewater Treatment Facility. The project consists of removing approximately 2,100 dry ton of alum sludge at the Wastewater Treatment Facility. This pricing is the result of a re-bid of this project for which the original bid was rejected by previous council action.

Contract documents were prepared by the City's consulting engineer, and bids were opened on May 12, 2016. A review of the bids has been completed with a recommendation of award to Environmental Solutions (US) Ltd. in the amount of \$1,290,700.00 With associated engineering costs, the total project is expected to be completed within the \$2,320,338.00 budgeted amount
