CITY OF BATAVIA – CONFERENCE MINUTES MONDAY, JULY 9, 2018

Present were Councilpersons Canale, Bialkowski, Viele, Briggs, Pacino, Tabelski, Christian and McGinnis. Council President Jankowski was absent.

Call to Order

Council President Pro Tem Viele called the meeting to order at 7:19 PM immediately following the business meeting.

To Submit a Community Development Block Grant (CDBG) Planning Application

Mr. Worth noted that this was authorizing the consulting firm to prepare a feasibility study for addition to the ice rink. The cost to the City is just the cost of the application and there is private funding for the match. Councilperson Bialkowski made a motion to move the item to the special business meeting following this meeting. The motion was seconded by Councilperson Christian and on roll call, approved 8-0.

To Amend the 2018-2019 Police Department Budget to Reflect the Receipt of a STOP-DWI Grant Amendment in the amount of \$1,668.07 to address the Crimes of Driving While Intoxicated and/or Driving While Ability Impaired by Drugs

Chief Heubusch was asking for authorization to amend the budget in order to receive the revenue. Councilperson Canale made a motion to move the item to the August business meeting. The motion was seconded by Councilperson Briggs and on roll call, approved 8-0.

Inter-Municipal Agreement – Antenna Installation on VA Water Tank

Jim Ficarella, Superintendent of Water and Wastewater, noted that the Town of Batavia asked to install an antenna on the water tank for meter readings. He noted that this is beneficial to the City as well because the mater meter readings can be done through that antenna. Councilperson Canale made a motion to move the item to the August business meeting. The motion was seconded by Councilperson Pacino and on roll call, approved 8-0.
