**WHEREAS**, the City of Batavia would like to accept a \$50,000 Community Development Block Grant Planning grant from the New York State Office of Community Renewal (NYSOCR) for a \$55,000 feasibility study to evaluate the possible addition of a second ice rink at the Falleti Ice Arena; and

WHEREAS, \$5,000 has also been provided by private sources for the feasibility study; and
