Subject:

New Police Station Bid Awards

The Department of Public Works issued a Request for Bids in October of 2023 for the New Police Station Project.

On November 21, 2023, bids documents were opened and reviewed by City, Architecture Unlimited, and Ashley McGraw Engineers staff.

- We received a total of seven bidders on the general contracting portion of the project. After reviewing all of the proposals, we chose to move forward with Building Innovation Group as the winning bidder for the project in the amount of \$5,468,698.
- We received a total of five bidders on the electrical contracting portion of the project. After reviewing all of the proposals, we chose to move forward with Kaplan Schmidt Electric, Inc. as the winning bidder for the project in the amount of \$1,365,500.
- We received a total of four bidders on the HVAC mechanical contracting portion of the project. After reviewing all of the proposals, we chose to move forward with Crosby-Brownlie, Inc. as the winning bidder for the project in the amount of \$1,897,200.
- We received a total of three bidders on the plumbing/fire contracting portion of the project. After reviewing all of the proposals, we chose to move forward with MKS Plumbing Corp. as the winning bidder for the project in the amount of \$895,000.
- We received a total of seven bidders on the site contracting portion of the project. After reviewing all of the proposals, we chose to move forward with Ingalls Development as the winning bidder for the project in the amount of \$1,559,500.

We recommended City Council to award the contracts at the December 21st, 2023 business meeting.

### Rachael,

Bids were submitted and opened publicly at 10:00 a.m. on November 21<sup>st</sup>, 2023 regarding five separate prime contracts for the above referenced project. The bidding was a result of robust public outreach and promotion, primarily thru the NYS Contract Reporter and the Construction Exchange of WNY.

In reviewing the bid process, as well as the bid evaluations conducted by the AE team led by Ashley McGraw, I can affirm that the AE has reviewed the bids in accordance with the provisions set forth in the Owner/Architect Agreement as well as Article 5 of the Instructions to Bidders provided in the Bid Documents. Of note:

§5.2 provides that "Unless otherwise prohibited by law, the Owner shall have the right to reject any or all bids".

§5.3.1 provides that "It is the intent of the Owner to award a Contract to the lowest responsive and responsible Bidder..." and further, that "Unless otherwise prohibited by law, the owner shall have the right... to accept the Bid which, in the Owner's judgement, is in the Owner's best interests".

Five (5) separate contracts were let as part of this Bid, each receiving at least three bids, and some receiving as many as seven bids.

Four of five bids successfully received a bid that can be judged to be both 'the lowest responsive bid' and the 'lowest responsible bid', those being Contracts 1, 3, 4 & 5 (General Construction, HVAC, Electrical, and Plumbing/Fire Protection).

As you are aware, the lowest bid for Contract 2, that being Site Construction received from Double A Services, could not be determined by our review to meet the standards for being judged 'the lowest responsive and responsible bid'.

This Bidder's amount was too far below both the AE's estimated costs for construction, as well as too far below the other market values presented by the six (6) other bids received. Double A Services could not provide satisfactory responses to the AE team to allow them to judge that the bidder would have enough resources to successfully complete the project work if a contract was awarded. Further, Double A Services was unresponsive to the City's separate invitation to come forth and meet with City Officials to review their bid.

As a result, it is my professional opinion and recommendation that the following be judged the lowest responsive and responsible bidders, and that the City accept the respective bids, and commence the process of entering into agreements, pursuant to the requirements of the Batavia City Council:

For Contract 1 – General Construction:
 <u>Building Innovation Group, Inc.</u>, in the amount of \$5,468,698.00

• For Contract 2 – Site Construction:

Ingalls Site Development, Inc., in the amount of \$1,559,500.00

For Contract 3 – HVAC/Mechanical Construction:
 Crosby Brownlie, Inc., in the amount of \$1,897,200.00

• For Contract 4 – Electrical Construction:

Kaplan-Schmidt Electric, Inc., in the amount of \$1,365,500.00

For Contract 5 – Plumbing Construction:
 MKS Plumbing Corporation, in the amount of \$895,000.00

Dear Ms. Tabelski:

Bids for the New Police Facility Project were received on November 21, 2023 at the Batavia City Council Chambers in Batavia NY. A copy of the bid tabulation sheet is enclosed for your information. A total of TWENTY SIX (26) bids were received for the FIVE (5) proposed prime contracts. At least THREE (3) bids were received for each prime contract.

Ashley McGraw has reviewed the bids as submitted and contacted the apparent low bidders to perform a "de-scoping" of their bid. De-scoping involves reviewing the bid forms for accuracy, confirming addenda were received and understood, review of bid security, checking past experience, and a general review of the scope of work to be performed. This is done so that the City ultimately awards the contract to the lowest responsible bidder.

Following the de-scoping process, we are able to provide this letter of recommendation of the following responsible low bidders to the City of Batavia for its approval for each prime contract.

Transportation Alternatives Program (TAP) grant

On September 29, 2023, Governor Kathy Hochul announced \$165 million in new funding is available under the Transportation Alternatives Program (TAP). TAP supports bicycle, pedestrian, multi-use path and transportation-related projects and programs. Projects support community-based investments designed to strengthen the cultural, aesthetic, and environmental aspects of local and regional transportation systems while promoting safety and mobility.

The funding is available for projects that create new and enhance existing bicycle and pedestrian facilities, improve access to public transportation, create safe routes to schools, convert abandoned railway corridors to pedestrian trails, and help reduce congestion and greenhouse gas emissions from the transportation sector.

The City of Batavia desires to install over 10,000 linear feet of sidewalks on South Swan, Swan, Jackson and Ross Streets to connect Jackson Elementary School with Batavia Middle School.

The TAP grant program provides up to \$5 million in grant funding for communities to implement alternative transportation projects, funding 80% of the total project cost. The 20% local match is typically covered by CHIPS funding received from New York State to support continual street maintenance.

Currently the project estimates are being refined but the total project cost is estimated to be \$1.2 million, making the City's local match approximately \$240,000. The City can use CHIP's funding in addition to other City funding as part of the City's local match.

I recommend that the City Council of the City of Batavia support the Swan, Jackson, and Ross School Corridor TAP application and continue to improve the City's sidewalk network.

### A RESOLUTION TO SUPPORT THE SUBMISSION OF A 2024 TRANSPORTATION ALTERNATIVES PROGRAM GRANT

**NOW THEREFORE, BE IT RESOLVED**, that the City of Batavia City Council does hereby enthusiastically authorize submission of the Transportation Alternatives Program grant for the sidewalk project

**BE IT FURTHER RESOLVED**, that the City of Batavia Council authorizes the City's share of the project to equal 20 percent of total project costs.
