The City of Batavia will be submitting a round 7 Restore NY grant to support the rehabilitation and repurposing of the long-vacant Carr's department store in the center of downtown into a mixed-use anchor. The Carr's project did not apply to the round 6 Restore NY grant as there were some interior drawings and engineering that needed to be completed to make the application more competitive.

The Carr's building consist of three existing connected buildings totaling approximately 27,000 sq. ft. The goal is to rehabilitate the first-floor commercial space and upper-floor apartments.

The Carr's Department store closed in 2001 and most of the building has been vacant for two decades. Revitalization of the DRI priority project will be transformational and propel Batavia's ongoing downtown revitalization momentum. In addition to being selected as a DRI priority project, the Carr's buildings are within the boundaries of both a BOA and former Empire Zone. The proposed project is also adjacent to three other DRI projects that have been completed or will be completed within the next year.

I recommend, City Council set a public hearing for January 9, 2023.

WHEREAS, an important goal of Restore NY is to revitalize urban centers, rural areas, and disadvantaged communities. It is anticipated that upon completion, the projects funded by Restore NY grants will attract individuals, families, and industry and commercial enterprises to the municipality. It is further anticipated that the improved community and business climate will result in an increased tax base thereby improving municipal finances and the where withal to further grow the municipality's tax and resource base, lessening its dependence on state aid; and

WHEREAS, cities with populations less than 40,000 can apply for up to \$2,000,000 in grant funding;

NOW THEREFORE, LET IT BE RESOLVED by the City of Batavia Council that it hereby authorizes submission of a Restore NY grant application not to exceed \$2,000,000 for the Carr's Reborn project in downtown Batavia.

BE IT FURTHER RESOLVED, that the City Manager of the City of Batavia, Genesee County, New York, is hereby authorized as the official representative of the City of Batavia to execute and submit the Restore NY application, all understandings and assurances contained therein, and is also hereby authorized to execute any grant agreements or documentation to implement the grant.

BE IT FURTHER RESOLVED, that project meets the following objectives:

- (1) The project is consistent with the City of Batavia Comprehensive Plan, Downtown Revitalization Initiative (DRI) Strategic Investment Plan, and Brownfield Opportunity Area (BOA) Plan.
 - (2) The proposed financing for the project is appropriate and committed.
- (3) The project facilitates effective and efficient use of existing and future public resources so as to promote both economic development and preservation of community resources.
- (4) The project develops and enhances infrastructure and/or other facilities in a manner that will attract, create and sustain employment opportunities where applicable.

Contract for Engineering Services, Bank Street NBRC Water Improvement Project

The City has successfully applied for and received funding through the Northern Border Regional Commission's (NBRC) program for the Bank Street Water Improvement Project. This project will involve the installation of an 8" NPS water main and the connection of existing customers as well as provisions for future development. The project will include the design, bid and construction of a water main improvement on Bank Street in the location between Main Street on the South and Washington Avenue on the North. The project has an estimated cost of \$418,000 with \$334,000 being grant funded.

The water main replacement on Bank Street from Main Street to Washington Avenue will involve installing a 950 linear feet of 8-inch diameter water main. This will include connection to the existing 12-inch water main at Main Street and a connection to the junction on an 8-inch and a 6-inch water main at Washington Avenue. There are six existing service connections that vary from 6-inch to 1-inch, that will be transferred to the new water main. A portion of Alva Place will be served by a short section of 8-inch water main for future development and added fire protection with a new fire hydrant. A new 6-inch service line will be stubbed to the site of a new police headquarters for both domestic and fire flows. Two existing fire hydrants will be replaced with new fire hydrants.

The water main abandonment portion of Bank Street is served by a 4-inch cast iron water main that appears to be original to the street. At some point in time, the former St. Jerome's Hospital expanded. In order to supply the increased need for water for the hospital site a short section on 6-inch water main was laid from Main Street to the Hospital's southern boundary. Estimates put this cast iron main as being nearly 90 years old. Both of these lines have had breaks over the years. Both the 4-inch and 6-

inch lines will be taken out of service once the new 8-inch line has been constructed, tested and services transferred.

This project will improve reliability, increase firefighting flows as well as being able to supply water needs for redevelopment projects in the important downtown business corridor.

To advance this project, an RFP was issued for professional engineering services to design and oversee construction of the project. Six professional engineering firms responded to the RFP, and City staff scored the proposals. After reviewing and scoring of the RFP's, I recommend Erdman Anthony for the engineering design, bidding and construction inspection services for the Bank Street Water Improvement Project for a total contract amount of \$XXXXXX.


It is recommended that Council approve the reappointment of Caroline Hosek to the Historic Preservation Commission until December 31, 2025.
