WHEREAS, the City of Batavia Police Department has received additional grant funding in the amount of \$5,000 from THE GENESEE COUNTY STOP-DWI PROGRAM TO COMBAT IMPAIRED DRIVING BY FUNDING SPECIALIZED PATROL FUNCTIONS; and

Effective November 14, 2022 amend the 202-23 budget:

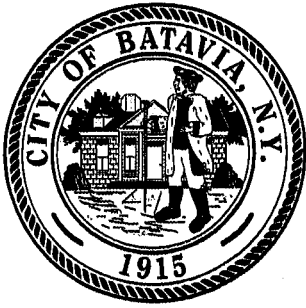

Subject: 2022-2023 STOP-DWI "High Visibility Engagement Campaign"

On October 12, 2022 the Genesee County STOP-DWI program awarded \$5,000 to the City of Batavia Police Department for the 2022/2023 High Visibility Engagement Campaign to be utilized during specific dates throughout the State's fiscal year.

These enhanced efforts include joint DWI patrols or checkpoints with other law enforcement agencies as well as reimbursement for Drug Recognition Expert (DRE) call-outs during the grant period (see the attached Grant Award letter for specific dates).

The City of Batavia will benefit greatly from these additional DWI details by enhancing the Police Department's ability to conduct more specialized enforcement details to target alcohol or drug impaired drivers.
